**14-041 – Introductions** – Two Presby Cats were introduced along with Rev. Wayne Boulton who spoke a few words about St Timothy's Chapel.

**14-042 - Docket** - The Docket was approved.

**14-043 - Welcome** – Lanny Rounds, Host Pastor, welcomed all and spoke on the facilities of the church.

**14-044 –Worship/Dwelling in the Word** – Dave Thompson led dwelling in the word which focused on two scriptures passages: Proverbs 22:6 and 2 Timothy 1:1-7. Dave also led singing by playing the guitar.

**14-045– Resourcing the Presbytery** – The theme of the meeting was "Making Young Disciples". Curt Kochner gave a presentation on the camping and youth retreat ministries of Yellowstone Presbytery. There was a video from Westminster Spires camping in 2013. Jody McDevitt gave a presentation on Rockhaven Camp along with a video. Dan Krebill along with Kori Roberts and Emily Keegan gave a presentation on the Presby Cats program that is sponsored by First Bozeman. They had a video of their mission trip to Ghost Ranch this spring. The Presby Cats thanked Yellowstone Presbytery for their financial support of their activities and their recent mission trip. George Goodrich presented information based on the book, *Sticky Faith*. The last portion of the resourcing time allowed people to attend two of four focus groups. The topics for these groups were: Multigenerational Opportunities, Equipping Parents, Beyond High School, and Youth Leading Youth.

**14-046 – Presentation of the Ballot from the Representation/Nomination Ministry Team**

**14-048 – Evening Worship** ó Worship opened at 7:00 pm. Elder Traci Ruschetti delivered the message centering on Matthew 28:16-20. Lanny Rounds presided over Communion and Paul Canon played the piano for this service.

**14-049 – Opening Worship** - Following a continental breakfast, provided by members of Butte First Church, Worship/Dwelling in the Word convened at 8:30 a.m. Teresa Kendall led dwelling in the Word using 2 Timothy 3:10-17. Lanny Rounds led singing and accompanied it with his guitar playing.

**14-050 – Hearing what the Holy Spirit is doing in Anaconda, Big Hole, Phillipsburg, and Butte** – Members and pastors from the four churches shared what is happening in their churches. A time of prayer for these churches followed the reports.

**14-051 ó Reports from General Assembly Commissioners** – Jim Tarr read a letter from TE Doug Johnson regarding his experience at General Assembly. Then Jim gave a report of his own experiences including his participation in the Committee for Presbyterian Mission Coordination.

**14-052 - Leadership Cabinet** – Jody McDevitt reviewed the report from the Leadership Cabinet ([See Attachment A](#)) and then introduced Dan Holland to receive any questions regarding the Budget and Finance Report ([See Attachment B](#)). Next Susan Thomas gave a report regarding Personnel issues..

√ Presbytery voted to approve that George and Kathy Goodrich move to a ½ time call with terms of call as shown on the handout ([See Attachment C](#)) to be effective October 1, 2014.

It was noted that a record of time worked in “off times” should be kept so that comp time could be allowed. Susan also presented an updated Job Description for the Co-General Presbyters ([See Attachment D](#)).
