Yellowstone Presbytery Leadership Cabinet met via Zoom for its scheduled meeting on Tuesday, September 9, 2025, beginning at 1:00 p.m.

1. Opening: Moderator Dave Thompson welcomed everyone and opened the meeting with prayer.

2. Dwelling in the Word: Members read from Philippians 4: 4-8 which reminds us to rejoice in the Lord always, something that is often easier said than done. In order to worry less, we are called to pray more which reminds us that the Lord is always near. The peace of mind that comes when we do this “guards our hearts and minds.”

3. Joys, Concerns & Spirit Sightings: Butte lost a pillar of their church with the death of Art. Ashley is seeking a new position. Bozeman looks toward transitioning to a new pastor. Also in Bozeman, Chandler is resigning from Rockhaven Camp Director. Pray for her and for the camp. Jamie has a court hearing today. Julie’s chemo seems to be working. Melissa is doing well. Kathy is grateful for vacation but concerned about George’s health, especially his tinnitus. Caroline’s grandson Weston and granddaughter-in-law Kailee were both baptized a week ago and grandson Clancy and Kailee were married last Friday. Baptisms were celebrated in Bozeman. Nearly every child in the Butte church attended their “VBS Without the BS” event. Five new members will join the Butte congregation on September 21st. Kathy enjoyed a grandson’s soccer game and was surprised when her grandchildren brought forward their new puppy. The Miles City church is partnering with Child Bridge, a foster parent support group. Their 1st meeting at the church was attended by 20 adults and 50 children. Jamie offered prayers and thanksgiving for our needs and celebrations.

4. Vision Statement: Ashley read the presbytery vision statement.

5. Minutes of August meeting:

***Action:** A motion was made and seconded to approve the minutes of the August 12 Leadership Cabinet meeting. The motion passed.

- 6. General Presbyter's report (Attachment A):** Kathy's written report includes a number of resources for people to review and use. She asks churches to help our younger attendees to develop their faith, find their purpose and develop community. Rep/Nom is having trouble finding people to serve. We are asked to pray for them and for people to rise up to serve. If you think of any names, send them to Kathy. Presbytery may need to set aside By-Laws to allow a some to serve on a team for a 7th year. Jamie is considering serving another year on our LC.
- 7. Presbytery meeting planning:** Paul and Lydia Neshangwe will be with us via Zoom from Zimbabwe. The theme is " Freed & Ignited to Live the Resurrection Life." Prizes will be given to the church that brings the most people to the meeting and to the church who have the highest percentage of congregants attending.
Dave agreed to come up with both a Mission project that people could participate in prior to the meeting and also fun fellowship activities for Friday evening.
- 8. Personnel Report:**
***Action:** The Personnel subcommittee nominates the following to the Transition Team: MWS Dave Thompson (LC Moderator), MWS Jamie Schmeling (Personnel Rep), RE Debbie Blackburn (PMT Rep), MWS Kimmy Briggs (general population), RE Danny Pratt (general population), Janet Anderson (general population). Nominees were elected unanimously.
- 9. Treasurer's Report (Attachment B):** Ric Tieman accidentally overpaid \$100.00 from the campus ministry fund.
***Action:** A motion was made and seconded to move \$100.00 from line item 3100.3 into the Campus Ministry fund to zero it out. The motion passed unanimously.
Ric received an Unemployment Insurance ruling that one of our camp counselors will receive unemployment payments. Since this is a contracted position for a limited amount of time, Ric was asked to appeal it. The appeal is due September 15. Dave will talk with the counselor who put in the application and explain why there should be no unemployment payments. "RAMP" credit cards have been ordered for staff. These cards will eliminate the need for vouchers. Ric and Caroline have already received their cards.
- 10. Camp update:** Sarah Tunall would like to continue as Moderator of the Camp & Youth Ministry Committee but will not serve as camp director. Sarah sent LC a resignation letter in August and should be informed that LC accepted it. There were questions voiced about her serving as moderator in the future and about her continuing on the committee due to differences, challenges in expectations, leadership style, and other things. Dave, Kathy and Jamie will talk with Sarah. Jamie (pastor/speaker for one of the camps this summer and on Personnel) and Kathy will attend Thursday's Camping and Youth zoom meeting. It was noted that Rep/Nom nominates the moderator annually and could choose to nominate another person as that team's moderator.
There are other concerns about the camp that need to be addressed in the coming year, including development of policies. The Camp committee will have input into these.

11. Clerk's Report: Caroline has a call in to Lori Griffith to talk about how a Korean Church in Bozeman might join our PC(USA) denomination. She is in contact with Sarah McDowell, the PC(USA) Annual Giving Officer with Stewardship Funds, has been working with a team to plan the October Presbytery meeting. She must call CLC to get herself listed as Stated Clerk only, not as General Presbyter, too.

12. Upcoming Meeting Dates: Presbytery Meeting October 3 & 4
LC Meeting October 14 & November 11

***Action:** Leadership Cabinet proposes the following dates for 2026 meetings: March 13-14, June 12 as a Zoom only meeting, & November 6-7. The motion passed unanimously.

We will ask churches to consider hosting a presbytery meeting. This may lead to at least one in-person only meeting in 2026, but LC believes it could increase participation from churches that have not attended in a while. A list of places we have met in the last few years, and the dates of those meetings will be available at the October presbytery meeting.

General Presbyter Report to Leadership Cabinet Rev. Kathy Goodrich August 12, 2025

Ps 46:10: *Be still/cease striving and know that I am God.* **QUESTION:** *Have you had opportunities to practice this during the summer, learn more about the practices which protect and cultivate this stillness, resting in and delighting in God? Or perhaps see how much this needs to be further worked into your life, pace as well as church practices?*

Julian of Norwich, in her *Showings*, [Classics of Western Spirituality Series]

And these words: *You will not be overcome, were said very insistently and strongly, for certainty and strength against every tribulation which may come. [God] did not say, You shall not be assailed, you shall not be belaboured, you shall not be disquieted, but God said, 'You shall not be overcome.' God wants us to pay attention to his words, and always to be strong in our certainty, in well-being and in woe, for [God] loves us and delights in us.*

John 16:33 *"I have told you these things, so that in me you may have peace. In this world you will have trouble. But take heart! I have overcome the world."*

Experimenting and learning our way forward – resources to explore and share

As change, transition and disruption continue at a rate around us in general, in the PUCSA and in Yellowstone Presbytery and our congregations, vitality in leaders and congregations is even more dependent than ever (unless one has chosen status quo and comfort which results in decline and death) on attitudes, and practices which cultivate:

spiritual formation/growth - Love for God and Christ-likeness

healthy Christ-like community and relationships across differences, generations...,

attentiveness to the Holy Spirit with an open, curious spirit,

practices of observation and prayerful reflection

Holy Spirit dreaming

adaptability experimenting/Learning one's way forward (usually innovative)

Many in churches find it wise to start with low hanging fruit and small experiments at the edges at the outset. A key priority and practice in vital churches is equipping pastors/CRE's and sessions/leaders to shift the understanding of the role of pastors/leaders from a maintenance, primarily chaplaincy model to that of Eph. 4:11+ that the leadership gifts are for equipping the saints for the ministry. Making disciples/apprentices who grow more like Christ and do and he did!

This includes learning contextual intelligence (*Contextual Intelligence* by Leonard Sweet and Michael Beck) Such experiments are ideal to involve not only "semi active" folks connected with a congregation but also others in the community. Various missional experiments and fresh expressions of church can become energizing for congregations to explore on this journey of discovery. Unless there is a significant move of the Holy Spirit, attraction is vastly less
