2025 Yellowstone Presbytery Moderator Melissa Bell, at the request of the Pastoral Ministry Team, calls a **Special Presbytery Meeting** on <u>Thursday</u>, <u>August 28</u> at <u>11:30 a.m.</u> on the following matters:

- 1. To examine Rev. Laura Wood and to act on PMT's recommendation that Laura Wood serve as a stated supply pastor at First Presbyterian Church, Deer Lodge, for a term no longer than 3 years and be received as a member of Yellowstone Presbytery. Statement of Faith Rev. Laura L. Wood Updated June 2025

I trust in the One God, Creator of the universe, and Sustainer of all. This Triune God is mysteriously and graciously revealed to the world as Father, Son and Holy Spirit. God's love for human beings knows no end, and is not bound, compromised or enhanced by our action. That love can never be earned nor eclipsed.

I trust in Jesus the Christ, fully human and fully divine, sent by God to be born among us, experiencing all the struggles and joys of this life. Jesus was a friend to sinners, a frustration to those who sought power, and a source of wisdom to those who had eyes to see and ears to hear. He healed the sick, comforted those who were oppressed, and called his followers to love others without consideration of gain or recognition. Ultimately he was betrayed, tortured and publicly executed. In complete obedience to God's plan, he accepted a punishment he did not deserve, so that we might receive mercy and grace. Through this perfect sacrifice he made it possible for us to be reconciled to God and to one another; saving us, redeeming us, transforming us that we might participate in his mission of transforming the world, and granting us reassurance for the life to come. We who follow Christ are a resurrection people.

Jesus promised those who followed him that he would never abandon them. While his physical presence did not remain long after his resurrection, his spiritual presence remains with us even today. ## Rev. Laura Wood Short Biography

Rev. Laura Wood is an ordained PC (U.S.A.) pastor and currently a member of Utah Presbytery. She received her Master of Divinity from San Francisco Theological Seminary and has served as pastor, associate pastor, or co-pastor to churches in Utah, Michigan and Iowa. She has also served as a PRN Chaplain, a volunteer hospital chaplain, and Utah's Executive Presbyter during her career. Laura is a native of the Belgrade/Manhattan area and was ordained to the ministry out of Manhattan Presbyterian Church.

Rev. Wood states she has a genuine love and compassion for people, her leadership style is friendly, approachable and informal. She especially enjoys working with smaller congregations and loves the core value of shared responsibility found there.

#### Of herself Rev. Wood writes:

"I approach my vocation with a sense of joy, curiosity and patience. I trust that without exception God provides us with all the resources we need to do the work that God asks us to do. Walking and working beside one another we can grow in our love for Christ, learn more about God's plan for our lives and our world, and experience the guidance and comfort of the Holy Spirit.'

# Covenant for Stated Pastoral Supply Between Rev Laura Wood and First Presbyterian Church, Deer Lodge, Montana Service from: October 9, 2025 to October 10, 2027

## Pastoral Responsibilities:

- Plan, prepare, and lead the worship services
- Administer the sacraments and officiate at weddings, baptisms, and funerals
- Be a teacher of the Word by providing spiritual and administrative leadership to the congregation, including its Christian Education ministries
- Moderate Session and Congregational meetings, train newly elected officers
- Serve as an ex-officio member of the Deacons
- Engage in pastoral care, such as hospital visitations when allowed, be aware of and provide support for those with special concerns and struggles
- Disciple, equip, empower and challenge members and friends of the congregation to grow deeper in faith, discover and identify their individual gifts, and participate in ministry and

mission; enabling them to know they are valued and needed in this body of Christ and sent into the world as Christ's ambassadors

- Be an active member of Yellowstone Presbytery
- Lead and equip the church in understanding, engagement with, and mission in the wider community
- Nurture one's own physical and spiritual life and love for God, engaging in regular spiritual practices, including Sabbath keeping, and praying for the congregation and community.

## Congregational Responsibilities:

- partner with the pastor in the shared work of ministry
- pursue an active faith life, seeking to continually grow in faith and respond to God's callings
- support the pastor in her ministry
- provide regular financial compensation according to the terms outlined below
- provide a performance review to the pastor at least annually
- pray for the pastor during this contract period
- participate in the wider ministry and mission of Yellowstone Presbytery, when needed/as appropriate

This agreement may be terminated by either party (session or pastor) upon 45 days written notice.

#### **TERMS:**

The pastor is employed on a two thirds basis serving approximately 26 hours per week, and will be compensated as follows:

Effective Salary split between Cash salary \$13,000 and Housing Allowance \$32,000 Board of Pensions fees Health (16%) \$7200 Reimbursable Medical flexible Spending account \$2000 SECA - \$3000

Professional Expense (mileage Books) Allowance \$1000 reimbursable Study allowance (can be carried over up to 3 years) \$600 Total Package \$58,800

#### Other benefits:

4 weeks of vacation including 4 Sundays
2 weeks of study leave including 2 Sundays
Follow the Yellowstone Presbytery Family Leave Policy as attached.

One time Moving costs - Negotiated.
