#### Leadership Cabinet Minutes Tuesday, June 8, 2021 via Zoom

1. Opening: Moderator Teresa Kendell called the meeting to order at 9:50 a.m.

Teresa welcomed Caroline Fleming as the newly installed Stated Clerk and thanked everyone for the prayers lifted for her family in recent days. The meeting was opened with prayer offered by Chuck Carlson.

- **2. Quorum:** Teresa declared a quorum present.
- **3. Dwelling in the Word**: Susan Thomas led the group in reflection and discussion on the scripture passage II Corinthians 5: 16-20 using The Message version that focuses on evaluating, befriending and working with people based on the central belief that Christ died for everyone.
- **4. Time for Prayer:** The group was separated into breakout rooms where personal concerns were shared and prayer was raised for one another.
- **5. Mini-Retreat:** Cabinet members shared their insights from Shannon Kiser's presentation at the May Presbytery meeting "Reconnecting our Churches with our Communities". Ideas for next steps about how to continue the work both individually and as the Leadership Cabinet as well as how to share the information with the presbytery's churches were offered.

Leadership Cabinet will ask people who are gifted, motivated and called to serve on a task force that will explore ways continue the discussion and enthusiasm generated from the May presbytery meeting workshop with individuals and churches in the presbytery. Leadership Cabinet members willing to serve on the task force are Russ Kline and Melissa Bell. Kathy Goodrich will serve as staff. Other names proposed were Marilynn Thomas of Deer Lodge, Karalee Larsen of Butte, and Kimmy Briggs of Lewistown. Teresa plans to talk with Marilyn Thomas concerning her interest.

It is noted that the workshop packet from Shannon Kaiser is being prepared for availability to persons in the Presbytery. It will be password protected and is not available online to the general public.

Susan Thomas closed the mini-retreat with prayer.

#### 6. Business meeting:

Note: At this point, Russ Kline, Dave Thompson and Susan Thomas had to leave the meeting. Moderator Teresa declared that we still had a quorum and would proceed with business.

- A. Three applications were received for Higher Education grants this year:
  - 1. MSU-Billings: Dwight Welch requested \$2000.00
  - 2. Rocky Mountain College: Kim Woeste requested \$1500.00
  - 3. Presby Cats (Bozeman): Dan Krebill requested \$2000.00

Cabinet members discussed the advantages of disbursing the entire \$6000.00 that is available now or of setting the unrequested \$500.00 aside for either new campus ministry seed funds or for needs that arise later in the year, such as assistance with a mission trip.

**A motion was made** to accept each application and award the amounts each grant asked for, reserving \$500.00 for use later. The motion was seconded and accepted unanimously.

Teresa will work with Ric Tieman in sending letters and checks to the three successful applicants. In August, Teresa will send letters to Miles City, Butte and Dillon to inform them that \$500 in funds are still available for campus ministry.

- B. **For the Record:** On May 28<sup>th</sup> at 10:00 a.m. by text it was voted to nominate Rev. Neva Rathbun (Terry) to Representation/Nominating Ministry Team for the class of 2021.
- C. Ric Tieman reported that Presbytery finances are good. (see Attachment A) Our accountant Elizabeth Linsky will be distributing reports. She will also generate budget sheets for both program and administration. For those needing reimbursements: vouchers are available on the website: yellowstonepcusa.org. Download a voucher, save it to your computer, fill it in, and send it to Ric.
- D. Presbytery has received a check for \$43,515.30 from the Harlowton Church sale. We still have to complete our settlement with the United Methodists concerning final expenses and insurance payments and/or reimbursement. Ric suggested the funds be set aside for now until a decision is made concerning the presbytery's office. They might be used for computers or

software, or a new website. For the future, Ric raised the implications of deciding to not have a physical office - Where will paper records be stored?

**A motion was made** to deposit the proceeds of the Harlowton church sale into the New Covenant Fund at the PC (USA) Foundation. The motion was seconded and was adopted.

Special thanks were given to Jamie and her family concerning the closing of the church in Harlowton and sale of the property. A suggestion was made that we might consider giving a tithe that would be advantageous to the Harlowton community. No action was taken.

#### 7. Announcements:

- 1. People were asked their opinion concerning the boundary training event held on Saturday, June 5. Those who attended were very enthusiastic, stating it was an excellent training session.
- 2. Dave Thompson and First Presbyterian Church, Billings are taking a mission trip to Zambia beginning June 21. We might ask for a presentation at a future presbytery meeting.
- 3. First Presbyterian Church, Billings will be conducting Vacation Bible School at Stanford this summer.
- 4. Dave Murchie, a UCC minister, was installed as pastor at Colstrip Community Church Sunday, June 6. People are encouraged to reach out and welcome him.
- 5. George and JP Carlson are leading a training program for interested lay leaders to develop their preaching abilities and pastoral care skills. The group meets on the first Tuesday of each month and several participants are already providing pulpit supply around the presbytery.
- 6. Next Presbytery Meeting dates: November 5 & 6

Cabinet members decided that the next meeting will be held on **Wednesday**, **September 8 at 9:30 a.m. via zoom**, provided the date works for members who were not present for the discussion.

A motion was made to adjourn the meeting, the motion was seconded and was adopted.

The meeting adjourned with prayer offered by Suzanne Bratsky at 1:00 p.m.
