Committee on Ministr Report 12 November 2011, Great Falls, Montana, Meeting

Recent Actions: Recommendation of Salary Minimums to Presbytery for Vote See Attachment #1

Request names for Administrative Commission for Susan Ennis's Installation Service at First Presbyterian Church, Poplar, MT. See Attachment # 2 for Approved Terms of Call and names for Installation Administrative Commission. She is being ordained by her presbytery of care, National Capitol Presbytery on 13 November 2011. Installation Date: Most likely in early January

We welcome Rev. James Kidd as member of Presbytery of Yellowstone. He's been on board with the Yoked Parish of First Presbyterian and American Lutheran Churches, White Sulphur Springs, since 01 October 2011. He will be installed during a worship service at 4:00 P.M. on Sunday, 20 November 2011. See Attachment #3 for Approved Installation Administrative Commission and Terms of Call.

On 06 July 2011 CoM interviewed Rev. Alice Kestler as a candidate at First Presbyterian Church, Lewistown, for the Yoked Parish of First Presbyterian and American Lutheran Churches, White Sulphur Springs, MT. CoM voted to support her as a fit for the White Sulphur Springs congregation should they vote to call her as their pastor. Rev. Kestler later declined the call.

Rev. Thomas Emery, as a candidate for First Protestant Church, West Yellowstone, on 05 August 2011 was interview by CoM members. By vote it was recommended that he would be a fit for First Protestant should they extend a call to him. A call was not extended to him by First Protestant.

Cathy McLean, CLP, at Federated Church in Forsyth has served for one year as Temporary Supply. Her evaluation by the session has been completed and CoM approved Cathy McLean's 2011-2012 contract agreement with Federated. Her hours were increased from 28 hours a week to 32 hours a week along with a corresponding increase in salary. See Attachment # 4.

CoM received report from Rev. David Schneider, Interim Pastor, serving First Presbyterian Church, Miles City, MT. His evaluation by the session and Co-General Presbyter, Rev. George Goodrich has been completed. CoM approved the new Covenant Agreement between agreed upon by both Rev. Schneider and First Presbyterian Church. See Attachment # 5

A Request from the Presbytery of Glacier that Jessica Crane-Munoz be ordained by the Presbytery of Yellow-stone for her call to serve as pastor to First Presbyterian Church, Cut Bank, MT. Jim Tarr, CoV, met with CoM to discuss the status of the Ordination Commission for Jessica. Since there was no meeting before her ordination date, 03 September 2011, Neva would receive names for the Ordination Administration Commission and send them out for CoM concurrence. CoM voted that 6 members would be from Yellowstone Presbytery and one from Glacier Presbytery. See Attachment # 6

With nFOG approved by vote of the Presbyteries of PC(USA), Rev. Kathy Goodrich, Co-General Presbyter led us through the areas of examination for ordination or presbytery membership. There is a need to ask each candidate some basic questions. Four areas of questioning were proposed which include:

- 1. What are your beliefs on each Ordination Question (2.0104b)?
- 2. Do you have any "scruples" regarding beliefs or practices?

- 3. What are your beliefs and practice regarding fidelity within the covenant of marriage between a man and a woman, and chastity in singleness?
- 4. What is the "fit" of gifts, experience and abilities between the pastor/CLP and the congregation or a validated ministry?

CoM received notification that Rev. Brentley Long would be leaving St. Andrew Presbyterian Church, Billings, MT. after High Holy Days in September. See Attachment #7

CoM voted to receive Candidate Susan Ennis into membership following the interview with Candidate Ennis pending her call by the Poplar congregation. Further, we requested that National Capitol Presbytery ordain Candidate Susan Ennis at its earliest convenience but no later than mid November of 2011. CoM voted to approve the Terms of Call presented for Candidate Ennis. See Attachment # 2

CoM voted to receive Rev. Jim Kidd into membership in Yellowstone Presbytery with a less than full time call to the Yoked Parish of First Presbyterian and American Lutheran Churches in White Sulphur Springs at the proposed Terms of Call. Further, the congregation and Rev. Kidd need to both understand that the part-time call is for a minimum of 41 hours per week and that Yellowstone Presbytery and Lutheran Synod involvement is to be counted as work time. Covenant Agreement -- Terms of Call Rev. David Schneider and First Presbyterian Church, Miles City, MT

This relationship shall begin effective 01 August 2011 until 31 July 2012 and shall not be renewed. Rev. Schneider shall be a member of Yellowstone Presbytery for the duration of this Covenant and is accountable to the presbytery through the CoM. Re. Schneider will provide written reports about his ministry every two months and participate with CoM and the Session in a final evaluation of his ministry at the end of the covenant year.

Covenant Termination Agreement: Thirty (30) days written notice by either the Interim Pastor or by the session. If terminated by the session prior to the end of the covenant period, compensation will continue for sixty (60) days after the date of termination of ministry.

TERMS OF DISSOLUTION

BETWEEN THE REV. BRENTLEY LONG AND ST. ANDREW PRESBYTERIAN CHURCH, 180 24TH ST WEST, BILLINGS, MT 59102-4770

The members of the St. Andrew Presbyterian Church Session agree to request dissolution of the pastoral relationship with the Rev. Brentley Long for the following reasons and on the following terms:

- 1. A letter of voluntary resignation was submitted by Rev Brentley Long at a stated meeting of the Session on July 19, 2011. The Session voted and accepted the letter of resignation at the July 19, 2011, meeting.
- 2. The terms of dissolution are that regular salary and benefits will be paid through November 30, 2011.
- 3. Time and date of separation:
 - a. The effective date that ministry duties will cease is September 4, 2011.
 - b. A congregational meeting will be called on August 21, 2011, to vote on the recommendation to dissolve the relationship between St. Andrew Presbyterian Church and Rev. Brentley Long and to approve the terms of dissolution.
 - c. Final acceptance of this agreement is subject to approval by the Presbytery of the Yellowstone.
- 4. If the parties fail to agree to these terms of dissolution, or if either party fails to comply subsequently with terms of the agreement, remedies for grievances will be sought through the Judicial Councils of the PC(USA).

The undersigned have made this agreement in good faith and have every intention of being faithful in fulfilling it.

On 09 August 2011 a request from the St. Andrew Presbyterian Session to CoM Moderator Rathbun for appointment of someone to moderate the Special Called Congregation meeting for the purpose to vote on Dissolution of the clergy/congregation relationship and the terms of Dissolution between Rev. Brentley Long and St. Andrew Presbyterian Church. With approval of CoM, Rev. David Thompson was asked to Moderate the Congregation meeting on Sunday, 21 August 2011, and to consider Moderating the Session meetings at St. Andrew through their time of transition. Rev. Thompson met with his Session at First Presbyterian Church, Billings, MT. First Pres. Session granted him permission to Moderate St. Andrew session meetings as necessary through their transitioning.

The CoM received the Terms of Dissolution between Rev. Brentley Long and St. Andrew Presbyterian and on behalf of Presbytery of Yellowstone with authority given them, CoM on 19 August 2011 voted to approve the terms of dissolution stated above.

Elder Russ Kline and Rev. Rathbun met with Rev. Brentley Long at Montana Grains for and exit interview. Then prior to the regularly scheduled session of St. Andrew Presbyterian Church, Russ and Neva met with them for an exit interview.

With Rev. Long's last day of service with the St. Andrew congregation being 04 September 2011, it also marked the conclusion of service as Parish Pastorate Associate for Rev. Priscilla Bell.
