- **09-72 -** Presbytery voted to grant **corresponding members**, together with Ric Tieman and Curt Kochner privilege of the floor.
- **09-73** Presbytery moved to assign this evening's worship service offering to Butte 1<sup>st</sup> for their upcoming medical mission trip to Mexico. (Offering was \$703.00)
- 09-74 Lanny Rounds welcomed presbytery to Butte.
- 09-75 Presbytery approved the Docket with addition of Saturday committee reports.
- **09-76** A report from the **Pastoral Team to Springhill** was made by Phil Maxwell, Freeman McCall, Jody McDevitt, and Sally Ralston.
- **09-76.1 Presbytery passed the following motion** by a vote of 39 to 10: "The Pastoral Team moves that the Springhill Presbyterian Church be dismissed from the Presbytery of Yellowstone to the Presbytery of the West of the Evangelical Presbyterian Church effective upon completion of legal and ecclesiastical details and receipt of Springhill Presbyterian Church by the Evangelical Presbyterian Church."
- **09-76.2 Presbytery passed the following motion** by a vote of 35 to 14: "The Pastoral Team moves that the Springhill Presbyterian Church be dismissed for a settlement of \$75,000 to be paid in five installments over five years, and that the other elements (listed below) determined by the Pastoral Team of Yellowstone Presbytery and the Dismissal Team of the Springhill Presbyterian Church be observed in the legal settlement yet to be drafted." Terms of the settlement will include:
  - a) a covenant not to sue
- b) agreement not to educate, or encourage other PC(USA) congregations, members or eaders regarding entering into the EPC
  - c) mutual up building (no slander or libel) between the Springhill Church and the Presbytery of Yellowstone
  - d) joint public statements
- e) submission of original Springhill Presbyterian Church session and congregational minutes to the PC(USA).
- **09-76.3 Presbytery voted to name an administrative commission** to handle details of the Springhill church dismissal at a special conference call Presbytery meeting on Monday November 23 at 7:00 p.m.
- **09-77** Susan Thomas and B.J. Otey led in prayer for the Springhill church and for the Presbytery.
- 09-78 Presbytery recessed for lunch at 12:30 p.m.
- **09-79** Presbytery reassembled at 1:30 p.m. for **Vision Team report** Ric Tieman, George Goodrich, Curt Kochner.
  - **09-79.1** Presbytery moved to adopt the following **Yellowstone Presbytery Vision Statement:**

John Calvin himself (Paul Krebill) made an appearance. They also noted that seven women from Yellowstone Presbytery attended this summer's Church-Wide National Women triennial gathering in Louisville. Mary Davis, Neva Rathbun, Suzanne Bratsky, Barbara Beardsley and Susan Gibb all reported on their trip.

# COVENANT OF UNDERSTANIDNG BETWEEN ROCKY MOUNTAIN COLLEGE AND

# THE PRESBYTERY OF YELLOWSTONE – PRESBYTERIAN CHURCH (U.S.A.)

To underscore the continuing relationship between Rocky Mountain College and the Presbytery of Yellowstone, to honor the ties that have nurtured the College since its beginning, and to build upon the heritage of support, trust, confidence, and achievement, Rocky Mountain College and the Presbytery of Yellowstone mutually affirm the following covenants:

# The College shall:

- 1. Publicly celebrate its heritage and affirmation with the Presbyterian Church (U.S.A.) and the Presbytery of Yellowstone.
- 2. Offer opportunities to engage in programs and activities of the College for the Presbytery and its churches and individual members.
- 3. Encourage the involvement of its students, faculty, staff and trustees in the programs and activities of the Presbytery and its member churches.
- 4. Offer educational opportunities for current and future leaders of the Church.
- 5. Offer opportunities for use of College facilities by the Presbytery and its institutional and individual members.
- 6. Offer opportunities for the Presbytery and its member churches to participate in the life, service and ministry of the College.
- 7. Maintain a concern for and provide ministry to the spiritual needs of the campus community.

# The Presbytery shall:

- 1. Publicly celebrate its heritage and affiliation with Rocky Mountain College.
- 2. Confirm and encourage its members as they are called to be Trustees of the College.
- 3. Endeavor to provide financial support to the College on an annual and predictable basis.

- 4. Offer opportunities for the College to encourage attendance by prospective students within the Presbytery.
- 5. Offer opportunities for presentation and discussion of the interests of the College at Presbytery and church meetings.
- 6. Offer opportunities and encouragement for students, faculty, staff, and trustees to be involved in the life, service, ministry of the Presbytery and its member churches
- 7. Recognize and support the College's ministry to the spiritual needs of the college community. (This will include membership in the Presbytery for the chaplain, if eligible.)

This Covenant of Understanding shall be presented to the Trustees of the College and the Council of the Presbytery for their review and approval at least every fifth year after its initial review and approval by those bodies, in accordance with their By-laws and other rules of order.

By the grace of God, in recognition and appreciation of God's gifts, and in order to provide glory and honor to God, Rocky Mountain College and the Presbytery of Yellowstone hereby pledge to uphold the covenants contained therein and to be faithful stewards of their mutual interests. In witness whereof, the duly authorized officer or agent of each has executed the Covenant of Understanding.
