Higher Education committee chairman, Bob Culbertson will prepare and submit Synod funding requests and forward Presbytery funding requests to Council for review.

II. We Request Council's *Input* on the Following:

a. Using the Christus Collegium settlement funds (lump sum or installment) to help fund the campus ministry programs within the Presbytery. The money was originally allocated for the purpose of campus ministry and with the withdrawal of Synod funding it will be very much appreciated to supplement the Presbytery's Higher Education funding.

- b. Use the Bozeman Campus Foundation (from the sale of the manse building in Bozeman) to help fund the MSU campus ministry program.
 The interest from this fund is currently going toward the Christus Collegium annual upkeep payments. In January when the payments cease we would like to see this fund's purpose be shifted to the MSU campus ministry programs.
- c. Use of the Convocation as a forum for informing and inspiring campus ministry program providers, possibly as early as Convocation 2012. Possible topics could be:
 - i. Current trends, values, and concerns of college students and how to respond to them.
 - ii. Programs that work and those that don't.
 - iii. Potential new programs for Christian witness and relationship building.
 - iv. Presenting Bible studies that are relevant.
 - v. Reconciling "Faith" with "Life" ("where the rubber meets the road")
 - vi. Building community and financial support for your ministry.
 - vii. Inspiring college ministry leaders.
- d. In light of the decreased funding for higher education programs and of Rocky Mountain College's unique ties to the Presbyterian Church, it is the recommendation of the Higher Education committee that:
 - Synod be encouraged to continue its relationship with Rocky Mountain College via active involvement and direct funding; and that
 - ii. Yellowstone Presbytery also strives to keep its special relationship to Rocky Mountain College via active involvement and direct funding
