- 12-116 Quorum Ron announced that a Quorum was present.
- **12-117 Instructions** The meeting Moderator, Don Holland, instructed all present who had comments or questions to identify themselves and to direct any question they may have to Dan Krebill.
- **12-118 Motion-** Dan Krebill moved that the presbytery give the session of the Bozeman 1<sup>st</sup> Presbyterian Church clearance to move ahead to the next steps of the process to purchase the Fearn Professional Building and property. Following the seconding of the motion Dan explained that the next steps included a payment of \$175,000 to close the purchase by April 30, 2013 and the signing of a mortgage for \$125,000 at that time. Dan noted that the congregation had voted to approve the purchase at a Congregational Meeting in November of this year. Dan also referred those present to the FAQ's that was sent out with the Call for the meeting.
- **12-119 Discussion** A series of questions were asked and Dan responded to those questions. The questions included the number of parking spaces that would be provided by this purchase (35-39) and whether the presbytery would be financially obligated in any way by the approval of this purchase (No).
- **12–120 Vote –** The presbytery voted unanimously in favor of the motion. Following the vote Dan thanked the presbytery, on behalf of the session and the Co-Pastors of the church.
- **12-121 Adjournment** Jody offered the closing prayer and Don adjourned the meeting at 7:57 p.m.
