13-061 – Dwelling in the Word – Vera White led this section. Her scriptural selection was Luke 10:1-9. She posed seven questions for discussion by small groups of 2-4 people. Following the small group discussions she transitioned to Resourcing the Presbytery (1001 Worshiping Communities).

13-062 – **Resourcing the Presbytery** – Vera continued with a presentation on 1001 Worshiping Communities. She shared a story of how the program got started in Pittsburgh Presbytery. She said that grant funds and resource people (coaches) are available for folks that are interested in implementing the program.

13-063 – **Co-General Presbyters Report** – George and Kathy presented their written report (See Attachment A).

13-065 – **Vision Structure Task Force Report** – Ric Tieman reviewed the past several years of the visioning process as well as the cloud document. Debbie Blackburn went over the proposed structure documents for Leadership Cabinet and Camping and Youth. Kathy reviewed the document for the Pastoral Ministry Team. Ric went over Representation/Nominating Ministry Team and PJC. George reviewed the Fifth Strand document. There was a time for

questions and comments on the proposed structure. It was noted that communications would be especially important with the proposed structure. Any further comments or questions should be sent to either Ric or Debbie by December 1, 2013.

13-066 – Standing Rules changes – 1^{st} reading – Dan Krebill reviewed the proposed changes to the standing rules. There were a few comments concerning the details of email voting. Any additional questions or comments should be sent to Dan by December 1, 2013.

13-067 – **Relief of Conscience** – **Manhattan Church** – Debbie Funke presented a request from the Session of Manhattan Presbyterian Church for the Presbytery to grant relief of conscience for the portion of their medical dues used to pay for abortions.

13-068 – **Mission Support** – There was a discussion regarding the suggested percentages for general mission pledges. Currently the split is: Presbytery 65%, Synod 23%, and General Assembly 12%. There was no action taken so the recommended percentages will remain the same for 2014. Churches may elect to allocate their pledges differently than the suggested figures.

13-069 – Leadership Cabinet Report – Don Holland read a request from the Leadership Cabinet that certain standing rules be set aside. The current standing rules state that the election of committee members shall take place at the last stated meeting of the year (S3.06) and to recommend annually to the presbytery a mission program and budget (S5.04.01) and to recommend annually an administrative budget to the presbytery along with the requisite costs to be assessed each church (S5.04.04). Except for the election of officers of the presbytery and the per Capita amount for 2014 these rules should be set aside until the Annual Meeting when a new structure might be adopted. The plan is to vote on a new structure at the February 2014 Presbytery meeting.

13-072 – **Synod Report** – David Ezekiel indicated that many changes are taking place at the Synod level. It is likely that Synods may be reduced to minimal responsibilities for PJC cases and administrative oversight. The Synod Coordinating Council has set aside \$150,000 to be used for funding of WNLT for five years. David also reported on what is happening in several other Presbyteries in the Rocky Mountain Synod. There was a time of prayer following this report.

13-073 – **Budget and Finance Committee** – Dan Holland brought a request to approve the Per Capita Rate for 2014. The Leadership Cabinet previously approved this request. The request is to approve a total rate of \$45.00 for 2014. This total amount is made up of \$7.02 for the General Assembly, \$5.75 for the Synod of the Rocky Mountains, and \$32.23 for Yellowstone Presbytery.
