## Presbytery of Yellowstone Special Meeting –October 4, 2013 Minutes

The Presbytery of Yellowstone met in a Special Meeting on Friday October 4, 2013 at 1:30 p.m. at 1<sup>st</sup> Presbyterian Church in Billings, Montana.

**13-056** – **Call to Order** — Moderator, Don Holland called the meeting to order. Jed Cauffman offered the opening prayer.

**13-057** – **Purpose of the Meeting** – Moderator Don announced the purpose of the meeting as it was stated in the Call for the meeting as follows:

- 13-059 Quorum Ron announced that a quorum was present.
- **13-060 Approval of the Docket** Don read the docket for the meeting. Presbytery voted to approve the Docket.
- **13-061 Introduction of Rev. Susan Barnes** Neva introduced Rev. Barnes and provided a few background comments on her as well as COM's work with her in the process.
- **13-062 Statement of Faith** Rev. Barnes read her Statement of Faith. Written copies were made available to those present.
- **13-063 Sermon** Rev. Barnes, with Neva Rathbun participating, presented a sermon which was based on Luke 10:25-37. The title for her sermon was "Gods Lawful Limits".
- **13-064 Examination of Rev. Barnes** Those present had copies of Rev. Barnes answers to the 9 questions COM asks of all prospective members of the presbytery. Members asked her a series of questions to which she responded.
- **ü** Presbytery voted to arrest the examination. At this point Rev. Barnes and her husband were excused.
- 13-065 Motion and Discussion On behalf of COM, Neva moved to grant membership, with concerns, to Rev. Susan Barnes into Yellowstone Presbytery as pastor of the St. Andrew Presbyterian Church, if the way be clear, and to authorize the Committee on Ministry to work with Rev. Barnes and the St. Andrew Church to arrange for an Installation Service for Rev.Barnes. A lengthy discussion, focusing on the concerns of COM, followed. Ron then clarified who was entitled to vote.

**ü** Presbytery voted to approve the above motion.

At this point Rev. Barnes and her husband were invited back into the Sanctuary and greeted with a standing ovation. The decision of the presbytery was announced by Moderator Don Holland.
