The Rep/Nom team is pleased to report that

- CRE Jack Bell from Billings first has accepted the one year at-large slot on the Leadership Cabinet for the class of 2015.

These two nominations need to be voted by the presbytery.

The team has completed a process for the nomination of Ruling Elders, Teaching Elders and Young Adult Advisor Delegates to the General Assembly. That process sheet is attached for your information.

We have also completed an application form for Young Adult Advisory Delegates and Ruling Elder Commissioners. Teaching Elders are selected on the basis of a point system. These applications are also attached.

We are urging all sessions to think carefully about folks from each congregation who might serve well as General Assembly delegates. Please be encouraging these folks to apply for General Assembly 2016. It meets June 18 - 25, 2016. Folks will need to be able to arrive a day or two before and YAAD must be between the ages of 17-23 years old on June 18, 2016 to qualify for this experience. PROCEDURE FOR SELECTING TEACHING ELDERS, RULING ELDER COMMISSIONERS AND YOUTH ADVISORY DELEGATES TO GENERAL ASSEMBLY

- The Representation/Nominating Ministry Team (Rep/Nom MT) will broadly announce opportunities to be considered as the Ruling Elder Commissioner (REC) or Young Adult Advisory Delegate (YAAD) to General Assembly during the winter and spring of the year prior to next General Assembly.
- Sessions and pastors shall be encouraged to look for qualified individuals
 and invite them to enter into the process to be considered as a Ruling Elder
 Commissioner or YAAD. Individuals may nominate themselves. YAADS Must be 17 -23
 years old the date the General Assembly convenes.
- 3. All individuals who are interested in being considered for this service will be required to complete an application and submit it to the Representation/Nominations Ministry Team by September 15th of the year prior to the next General Assembly.
- 4. All applicants (YAADS and RULING ELDER COMMISSIONERS) shall send a copy of their application to the Representation/Nomination Ministry Team, which will then seek an endorsement from the home session of the applicant.
- 5. The Representation/Nomination Ministry Team will review the applications from Ruling Elders and YAADS and select nominees and alternates based on their record of love for Christ and Christ's church, spiritual and emotional maturity, experience in serving in the church and presbytery, proven character, integrity, grace and ability to endure long hours of meetings and in-depth discussion of emotional and controversial issues, availability to train and prepare for the assembly, etc. The Representation/Nominations Ministry Team shall then re-confer with those selected as to their willingness and availability to actually attend the next General Assembly.
- 6. The Representation/Nominations Ministry Team will review the current point list for teaching elders which is kept by the Stated Clerk and consult with the individuals in the top positions to determine willingness and availability to attend the next General Assembly. A delegate and an alternate shall be selected and confirmed.
- 7. The Representation/Nomination Ministry Team shall complete their work at least 3 weeks before the stated fall presbytery meeting and post these names along with nominees to other positions as a part of their report that will be voted on, at the fall meeting.
- 8. In case of a nominee or alternate becoming unable to serve, the Representation/Nominations Team will confer with the next name on their list and notify the Stated Clerk of the vacancy and new nomination.
- 9. The Elder Commissioner who is the alternate for one General Assembly will normally be the Elder Commission for the next General Assembly if they chose to apply.
