- **23-051. Dwelling in the Word**: Julie Boksich led the group in Dwelling in the Word based in II Corinthians 4: 7-12. People met in small groups to discuss the passage and joined together to share thoughts that arose including that God is with us in our brokenness, we have the strength of Christ, the Gospel is a treasure, we are never crushed, and we move forward with the Spirit's help. Julie ended our time with prayer.
- **23-052. Spirit Sighting:** Karolee shared that the Butte church has been in a Year of Jubilee. Taking a break from new programs. It has helped members relax. The church will welcome four new members on November 5, and more are thinking about joining. A quiet corner has been created in the front of the sanctuary where children's activities are available. The church is seeing "fruit from the harvest" after the time of Jubilee.
- **23-053 Workshop: Mining the Scriptures Daily for Hidden Treasures:** Rev. Dr. Tim Slemmons led presbyters in a workshop that focused on the Bible as the whole counsel of God and how Christians would be wise to become addicts for the Word. The workshop is recorded.
- **23-054** Workshop: The Church in Flight: How to Travel Lighter and Sort for the Season: Rev. Dr. Beth McCaw challenged presbyters to consider what we must leave behind as we, the Church, travels into the future and reminded us that new people cannot participate in what we were, only in what we are becoming. The workshop is recorded.

Kathy prayed for Time and Beth and the Spirit at work in them before presbyters adjourned for a break.

23-055 Spirit Sighting: Rev. Dan Triller and Tori Krieger of Dillon shared the Spirit at work in the Dillon Church through Presbytery's help with funding Tori's intern position. She is providing ministry to youth and families and planning intergenerational activities.

- **7.** That the draft minutes of the Presbytery meeting of June 16, 2023 be approved as published on the presbytery website.

23-061 Opening Prayer and Dwelling in the Word: Yellowstone Presbytery reconvened at 8:40 a.m. with prayer and Dwelling in the Word led by Melissa Bell. Presbyters read Isaiah 43: 15-19, and in small groups discussed how God is doing a new thing and are we perceiving it.

23-062 Camping and Youth Team Report: (Attachment G) Dan Triller reviewed the 2023 camping program. A one-week camp was held at Hyalite Camp since our Westminster Spires Camp could not be prepared in time for the season. Fifty-four campers and 24

volunteer leaders enjoyed a week of learning and fellowship. The presbytery's camp will return to Westminster Spires in 2024. The team might try a family camp, and there will be a "revamp the camp" event in June. One repair that must be made is to get the propane tank back on its foundation.

The team hopes to hold a youth ski retreat this winter. Look for more about this event in the new year.

23-063 Representation & Nomination (Rep/Nom) Team Report Part 2: (Attachment F)Jody McDevitt give the second reading of names of those nominated by the Rep/Nom Team to offices and teams beginning in 2024.

*Action: Moderator Melissa Bell called for nominations from the floor three times before calling for a vote on those nominated. The motion passed.

The Rep/Nom Team recommended the following proposal which changes the way MWS General Assembly Commissioners are chosen:

The Stated Clerk will keep a record of the following for each member of the presbytery:

- Status (Engaged in a Validated Ministry, Member at-large, or Retired)
- Ordination date
- Date of joining Yellowstone Presbytery
- Excused absences from presbytery meetings for the previous 2 years
- Unexcused absences from presbytery meetings for the previous 2 years
- Receipt of annual reports for the previous 2 years from retired ministers, ministers-at-large and those serving in validated ministries but not as installed pastors in Presbyterian churches.
- Year when member last served as GA Commissioner.

To be eligible for consideration, a Minister of Word and Sacrament must be engaged in a validated ministry, a member at-large, or retired. Temporary Members from another Christian church will be ineligible.

The Representation/Nominating Team will consider the above factors, as well as the following factors, to prayerfully nominate a Minister Commissioner and Alternate.

- Engagement in the work of the presbytery
- Diversity (across the years of GA) of gender, age, and ethnicity
- Leadership potential for the future of the presbytery and larger church

The annual Representation Report was presented:

There are 4 Moderator roles currently filled. Of these, there are:

2 men, 2 women: 1 ruling elders, 3 ministers of Word and sacrament We recommend that the vice-moderator of the Presbytery should be a male Ruling elder to balance these leadership roles and bring greater balance to the Leadership Cabinet.

There are 41 elected positions filled at this time. Of these, there are:

18 men, 23 women: 23 ruling elders, 18 ministers of Word and sacrament We recommend that the Leadership Cabinet seek male representation on the Rep/Nom Team.

^{*}Action: The recommendation passed.

Geographical representation:

9 are from the eastern region of Yellowstone Presbytery (8 churches), 21 are from the central region of Yellowstone Presbytery (7 churches), 11 are from the western region of Yellowstone Presbytery (7 churches), Ruling Elders come from 11 of our 22 churches.

We recommend seeking more representation from the eastern and western regions, as well as encouraging participation of the 11 churches not currently represented in presbytery roles.

Age representation:

26 are 60+ years of age, 7 are 40-59 years of age, 8 are under 40 years of age (Many of these ages are guesses!)

We recommend paying attention to this imbalance and encouraging young leadership, making accommodations in our time expectations as much as possible.

Race/ethnicity/culture

To our knowledge, only one person serving Yellowstone Presbytery checks a "non-White" box. This is reflective of most of the membership of our congregations, but also a reminder that our congregations do not represent the growing diversity in the state of Montana.

We recommend increased awareness and openness to the gifts of God's diverse people in our communities.

*Action: A motion was made and seconded to receive the Representation Report. The motion passed.

- **23-064 Synod Commissioners' Report:** CRE Margee Smith and MWS JP Carlson attended the Synod meeting in Utah. General Presbyter Kathy Goodrich attended virtually. Margee accepted a lead role on the Gellar Grant team. The grant must be applied for by two presbyteries and focus on leadership development. Commissioners viewed 5-minute videos of most of the presbyteries. Yellowstone Presbytery has not yet submitted a video.
- **23-065 Presbyterian Women Report (Attachment G)** Suzanne Bratsky reminded people that the Churchwide Gathering of Presbyterian Women will be held in the summer of 2024 in St. Louis Missouri.
- **23-066 St. Timothy Chapel:** Cal Boyle reviewed the history of St. Timothy Chapel and reminded presbyters that the chapel serves an ecumenical ministry. The facility accommodates 140 people and is open From June 1 through the last Sunday of August each year.
- **23-067 Stated Clerk Report (Attachment H):** Caroline Fleming pointed to her activities since the June Presbytery meeting and noted that she will be joining members of the Presbyterian Self-Development of People Committee (SDOP) on a site visit to The Center Pole in Garryowen, MT on November 7. SDOP is considering granting funds to The Center Pole based on a grant application they submitted to the program.
- **23-068 Spirit Sighting:** Ashley Birk and Suzanne Bratsky shared how the Spirit has been working among the people of Bozeman and the staff of the Rockhaven Camp since the sudden death of the Camp Director during the camping season. After addressing crisis response and lots of vision work as the board and others thought about the future of the camp, Chandler Joiner, who has a background in religious education has agreed to serve as the next Camp Director. God provided.

23-069 CRE Training through Dubuque Seminary: Beth McCaw reported on the development of a Commissioned Lay Pastor course in conjunction with the Synod of the Rocky Mountains and Dubuque Theological Seminary (DTS). The program offers an opportunity for anyone to strengthen their ministry. A person can take one course or the entire two-year program. There will be 8 classes offered over the two-year period. More information can be found on the presbytery website and the DTS website.

23-070 Announcements:

- Tim Slemmons gave people the gift of CDs, music of relevant psalms and contemplation.
- Everyone was invited to take bookmarks created by Karolee Larson that included this meeting's theme and the presbytery vision statement.

Debbie and Neva have done an amazing job as co-moderators. We owe them a huge debt of thanks.

There is a wide range of pastoral and/or "work" interactions with presbytery leaders, pastors/CRE's, sessions, PNC's. Please pray for all our churches as well as Important transitions, searches in several churches require a great deal of time and prayer from me, PMT, as well as their church. And several of you all who are sharing your gifts in the ministry and have no pastor at this time.

A pioneering partnership for the presbyteries in our Synod with Dubuque Seminary, Rev. Dr. Beth McCaw, former Glacier GP, and heading this up. Dubuque faculty working in partnership with Synod presbyteries on this. (Several grants are a part of the funding for this experiment). This opportunity is for both those who are interested in the full program as well as those who may want to take a course or 2. Those in the 2-year program will meet together 2x a year. A zoom planning meeting 6/15 was very impressive and encouraging for a host of reasons.

Pray and ask! Please promote this opportunity in your churches

CLC – connecting, discerning, calling is rolling out and training for the NEW CLC (Church Leadership Connection, pastor church 'dating 'service!). After attending a National Webinar in May for presbytery staff & COM mod's, this has been and will continue to require a great deal of learning, adapting and interpretive time and energy for me, Caroline, our PMT leaders and any involved in search processes. There are some improvements and adaptations. Yet, the rollout has been bumpy as the new forms, instructions, manuals, FAQ's, have not been available or else not finalized to coincide with rollout and some training and the full operation of the new system. Many Presbytery staff, COM's and PNCs are very frustrated, not receiving responses to requests for the needed improvements or explanations much of the time. EPs are now needing to function as networkers to share pastoral opening and locate pastors. The system in not providing many quality or sufficient candidates to PNC's and EPs are impeded in gaining information needed.

Pastoral Ministry Team's Report November 2023

The purpose of the Pastoral Ministry Team is to come alongside of churches, sessions, pastors and CREs to provide encouragement, support, and training as we work together to share the Good News of Jesus Christ.

Information Items

PMT approved the contract between CRE Veva Larson and the Anaconda church for a period of one year (See attachment).

PMT voted to concur with the dissolution of the pastoral relationship between MWS Teresa Kendall and Deer Lodge 1st Presbyterian Church effective August 31, 2023.

PMT voted to appoint RE Debbie Ernst and MWS Freeman McCall as co-moderators of the Deer Lodge session effective September 1, 2023.

PMT voted to recommend MWS Freeman McCall to fill the pulpit and serve as part-time pastor for Deer Lodge for the next season, beginning October 1, 2023. due to the vision, energy, and gifts he brings.

PMT voted to recommend approval of a request from MWS Freeman McCall to labor outside the bounds of Yellowstone Presbytery to serve the Presbyterian Church in Cody, Wyoming in August and September.

PMT approved the proposed contract between MWS Freeman McCall and the Deer Lodge Church (See attachment).

PMT reviewed and approved the Ministry Discernment Profile (MDP) for the Miles City church. Miles City is now in the process of receiving and reviewing potential matches.

PMT approved the Mission Study for the Bozeman First Church and granted approval for the nomination of a Pastor Nominating Committee.

PMT approved amending the proposed contract between MWS Freeman McCall and the Deer Lodge church to include the new start and end dates of October 15 and December 17.

PMT approved RE Jim Tarr and RE Melissa Bell as co-moderators of the Stanford Church session.

PMT has received some of the annual reporting paperwork for validated ministries, members-at-large, and honorably retired clergy. Several pastors have not yet returned the required reports.

PART 2 - Selection Process for Minister Commissioner to General Assembly

BACKGROUND TO PROPOSAL

Current official process:

- NOT ELIGIBLE: At-large members, Out-of-Bounds members, non-PCUSA members, temporary and interim pastors, Honorably Retired members
- Points are earned for:
 - 1. Each year since ordination
 - 2. Each year since joining Yellowstone Presbytery
 - 3. Years since service as GA Commissioner
- Points are subtracted for:
 - 1. Unexcused absences from presbytery meetings in current year

Recent practice and observations about that practice:

- Presbytery staff have not been asked to serve in this role (or have declined), due to concerns expressed by some over potential conflicts of interest.
- Rep/Nom has weighed more heavily the <u>active</u> role of ministers in the presbytery.
- Interest in being Commissioner has decreased.
- With fewer pastors serving churches, we have a smaller pool to choose from

In 2019, Rep/Nom asked the Leadership Cabinet to revise the system. The LC asked Rep/Nom for a proposal.

Then came 2020. . . . and here we are, 3 years later.

PROPOSAL (Highlighted portions are revisions)

The Stated Clerk will keep a record of the following for each member of the presbytery:

- Status (Engaged in a Validated Ministry, Member at-large, or Retired)
- Ordination date
- Date of joining Yellowstone Presbytery
- Excused absences from presbytery meetings for the previous 2 years
- Unexcused absences from presbytery meetings for the previous 2 years
- Receipt of annual reports for the previous 2 years from retired ministers, ministers-at-large and those serving in validated ministries but not as installed pastors in Presbyterian churches.
- Year when member last served as GA Commissioner

To be eligible for consideration, a Minister of Word and Sacrament must be engaged in a validated ministry, a member at-large, or retired. Temporary Members from another Christian church will be ineligible.

The Representation/Nominating Team will consider the above factors, as well as the following factors, to prayerfully nominate a Minister Commissioner and Alternate.

- Engagement in the work of the presbytery
- Diversity (across the years of GA) of gender, age, and ethnicity
- Leadership potential for the future of the presbytery and larger church

PART 3 – Representation Report

Our analysis of those serving in elected positions in Yellowstone Presbytery follows. Recommendations are highlighted in red.

There are 4 Moderator roles currently filled. Of these, there are:

2 men, 2 women

1 ruling elders, 3 ministers of Word and sacrament

We are still in the process of filling leadership roles, with 2 additional roles to be filled. We recommend that the vice-moderator of the Presbytery should be a male Ruling elder to balance these leadership roles and bring greater balance to the Leadership Cabinet.

There are 41 elected positions filled at this time. Of these, there are:

18 men, 23 women

23 ruling elders, 18 ministers of Word and sacrament

These balances tip towards women (as does the balance in most congregations) and toward ruling elders. The 2023 Representation/Nominating Team is all women. Several of the ministers of Word and sacrament in our small presbytery are serving on two ministry teams.

We recommend that the Leadership Cabinet seek male representation on the Rep/Nom Team.

Geographical representation:

9 are from the eastern region of Yellowstone Presbytery (8 churches)

21 are from the central region of Yellowstone Presbytery (7 churches)

11 are from the western region of Yellowstone Presbytery (7 churches)

Ruling Elders come from 11 of our 22 churches.

The boundaries between these regions could be drawn differently, yielding a different count. The central region includes the largest congregations.

We recommend seeking more representation from the eastern and western regions, as well as encouraging participation of the 11 churches not currently represented in presbytery roles.

Age representation:

26 are 60+ years of age

7 are 40-59 years of age 8 are under 40 years of age

(Many of these ages are guesses!) This distribution is similar to one year ago. We have younger minister members who are taking on more roles in the presbytery. The time demands of presbytery service are more easily met by ruling elders who are retired than those who are younger and working full-time.

We recommend paying attention to this imbalance and encouraging young leadership, making accommodations in our time expectations as much as possible.

Race/ethnicity/culture

To our knowledge, only one person serving Yellowstone Presbytery checks a "non-White" box. This is reflective of most of the membership of our congregations, but also a reminder that our congregations do not represent the growing diversity in the state of Montana.

We recommend increased awareness and openness to the gifts of God's diverse people in our communities.

I received 29 "Yes" votes and we needed 33. We did receive 2 abstentions, but they do not count toward the tally.
