- üApproved Grant of \$750 for Cathy McLean, CRE from the Linda Hofer Education Fund. The rationale is that she has completed requirements and is commissioned as a CRE. She is continuing her education

üReceived report from TE Aline Russell, Interim at St. Andrew Presbyterian Church West Yellowstone has been accepted by the Evangelical Presbyterian Church and an Administrative Commission has been established by EPC. At this time the attorneys are reviewing and finalizing the Dismissal Agreement that was approved by Presbytery at the November 2/3,

- 2012. Moderator Rathbun, on behalf of CoM requested appropriate liturgy for dismissal of West Yellowstone Protestant Church during a worship service of Presbytery Meeting.
- Deer Lodge The PNC continues to search for part-time or tent-making person. Let's continue to stand with them in prayer.
- Com members have received a brochure entitled "For Such a Time as This". This is a project for qualifying congregations "Where the needs of Christ's church and the gifts of first-call pastors meet."
- Liaisons for TEs, CREs, CLP, and congregations--As soon as all assignments have been made, the list will be sent out to pastors and stated clerks.
- The Clergy Emergency Fund has been depleted. When the fund was established, it was determined that three thousand dollars (\$3,000) was to be maintained in the Fund. A request for the offering to be designated for the Clergy Emergency Fund during the Feb 22-worship service service.

CoM is in the process of re-evaluating the 2012 Goals and up-dating them for 2013.
