Costs and Procedures for Renting

A deposit is required to reserve your space. It is refundable up to two weeks before the camp date. The deposit will be considered a damage deposit. If there is no damage, then it may be applied to the rental fee.

Costs:

Meadow usage and outhouses for the facilities. \$50 per day -\$25 deposit Meadow usage and craft hall and outhouses for the facilities. \$100 per day -\$50 deposit

Prouty Hall and the Restrooms. \$150 per night -\$75 deposit

Prouty Hall and the Restrooms and 1 cabin. \$250 per night -\$100 deposit

Prouty Hall and the Restrooms and 2 cabins. \$500 per night -\$200 deposit

Prouty Hall and the Restrooms and 4 cabins. \$750 per night -\$200 deposit

Full camp and all the cabins. \$1,000 per night -\$200 deposit

Camp Rules:

Telephone calls: All long distance calls are to be made collect or with a credit card; there is no long distance available.

Protect the camp and all structures, equipment, and improvements at the camp from trespass, fire and destruction. The Renters agree to pay for any and all damages and any loss of equipment furnished by Westminster Spires.

Fires only permitted in designated fire rings. Observe all fire prevention and safety precautions.

Enter and leave the camp on the dates specified in the reservation*****. Leave the camp completely cleaned and ready for occupancy by the next group. Remove all trash to the bear-proof dumpster.

No pets are permitted in the food service and health service areas. All pet droppings in the general walking and activity areas of the facilities are to be picked up and disposed of in the dumpster.

Please obey all Forest Service rules including for your pets. You are on leased Forest Service property.

No cutting or mutilation of any live timber, shrubbery or other growth on the premises.

No firearms or fireworks on the premises at all.

Vehicles are permitted in designated areas only.
